GROUP TERMS AND CONDITIONS

This agreement between the National Conference of State Fleet Administrators Group (NCSFA) and **The Westin Savannah Harbor** ("Club") is for golf starting times in conjunction with the (NCSFA) event at **The Club at Savannah Harbor**.

Golf starting times are scheduled in 9-minute intervals. In order to fully maximize golf inventory while avoiding the mixing of golf pairings with other resort guests and members, each starting time is allocated in its entirety, 4 players per starting time and charged as such, unless the (NCSFA) group waives the exclusivity of the starting time and is designated below.

Shotgun starts will run in conjunction with other tee times, unless the (NCSFA) group books course to the full capacity of 128 players. The golf course will reserve the right to assign the number of and specific starting holes for all shotgun outings.

Dress Code Women: Dress, skirt and blouse, slacks or shorts.

All denim and jeans and /or cut- offs are not permitted for men or women at any time.

Inclement Weather Policy

The Club at Savannah Harbor reserves the right to close the golf course due to inclement weather. Should inclement weather close the golf course and the course is deemed unplayable by the management of The Club at Savannah Harbor, the following rain check policy applies:

1. If the group has played 3 holes or less, they will not incur any charges for green fees for the contracted event.
2. If the group has completed 4-9 holes, they will be charged one half the rate as quoted in the contract.
3. Any group who has played more than 9 holes will be responsible for the full amount as per their contract.
4. This policy applies to green fee charges only.
